Privacy and Confidentiality Policy

Definitions

Ticket: pass issued by the Organiser and allowing access to its Event

Event: professional event organised by the Organiser using the InvitYou platform

Guest: Anyone invited to or participating in an Event

Organiser: InvitYou user who organises an Event

Registration Website: Website allowing guests to register for the Event

Role of the Policy

This policy is intended to inform you of our commitments with respect to your privacy and the protection of personal data concerning you, collected and processed during your registration for the Event.

By registering for the Event, you agree to provide true and genuine information about yourself.

Controller

The controller of your personal data is the Organiser, as a supplier we process your data on behalf of this one.

Data collected

The only data we collect is that required for the provision of service and is mainly as follows:

- Contact details (surname, first name, address, e-mail address or, for legal persons: name, corporate form, registered office, billing address, e-mail address, etc.)

As the Organiser is completely autonomous in the creation of its registration form, we may collect other data, this being limited to the data that will be requested by the Organiser as part of the management of its Event.

The mandatory or optional nature of the data is signalled to you during collection by an asterisk.

Purpose of the data collected

The collected data is intended to allow:

- Registration of your participation in the Event by the Organiser;
- Your care by the Organiser during the Event;
- The management of your Ticket orders, in particular their delivery, and the ability of the Organiser to contact you, in particular in the event of cancellation of or change to the Event;
- The establishment and maintenance of legal documents in accordance with accounting standards.

Information and data are also kept for security purposes in accordance with legal and regulatory requirements.

Recipients of your data

We guarantee the confidentiality of the information you have transmitted, and we shall not communicate it to anyone other than those who are entitled to it for the management and delivery of services provided, including our external service providers (payment solution provider, IT subcontractor, web host, email router).

The personal data provided shall not be the object of any commercial exploitation on our part and shall not be transmitted to anybody for commercial purposes or commercial prospection.

However, we reserve the right to communicate this personal data upon judicial requisition, in all cases imposed by law and in cases where this communication would be necessary for the defence of its interests during any procedure, judicial or otherwise.

Furthermore, by accepting the terms of this Privacy Policy, you consent to our transmission of your personal data to the Organiser, in order to allow the proper execution of the Event it organises, which remains solely responsible to you for the use of the transmitted data as additional data that it collects from you.

Security measures

We have implemented appropriate technical and organizational measures to ensure the security of your personal data in order to prevent any unauthorized or unlawful processing of this personal data and to protect against accidental loss or destruction of personal data or damage to it.

Retention of personal data

Personal data is not kept beyond the period necessary for the purposes pursued.

Payment Security - Bank Data

We use the STRIPE payment solution for online payment for Tickets.

Your bank details are collected by STRIPE, which uses an encryption algorithm (PCI certification level 1), the highest level of certification.

This banking solution is PCI DSS certified by VISA and MASTERCARD: this standard is an international security standard whose objectives are to ensure the confidentiality and integrity of cardholder data, and thus secure the protection of card and transaction data.

We do not keep your bank details.

Your rights under the Data Protection Act

In accordance with the provisions of Law No. 78-17 of 6 January 1978 relating to data processing, records and privacy, supplemented by the RGPD (General Data Protection Regulation) entered into force on May 25, 2018, you have the right to access, consult, modify or rectify your data as well as the right to object to your data being processed.

You can exercise your rights of access and modification concerning this data directly with the Organiser, through the "contact form" available on your Registration Site.
